Rental group:
Cylinders are classified into rental groups according to size, content and application. We summarise your cylinder movements by rental group.

Net billable days:
The number of billable days less the number of prepaid days. Billable days are divided into Tier 1, Tier 2 and Tier 3 days according to the length of time that cylinders have held at your site location.

Tier 1 days:
Number of billable days related to cylinders that have been in your holdings for 3 months or less.

Tier 2 days:
Number of billable days related to cylinders that have been continuously in your holdings for more than 3 months but less than 6 months.

Tier 3 days:
Number of billable days related to cylinders that have been continuously in your holdings for more than 6 months.
